## RULES & REGULATIONS

1. Ribbons will be to 3<sup>rd</sup> place (where applicable) and the Judge's decision is final.
2. Supreme Led Foal of show is to be judged at the completion of the Ring. Champions from each section are eligible.
3. Where sponsorship prizes/trophies are applicable, failure to collect these awards on the day of the show may result in those awards being forfeited.
4. Age of all foals to be calculated as from 1st August 2011.
5. All protests must be lodged in writing with the show secretary at the office within 30 minutes of the event and accompanied by \$50.00 cash.
6. The NSW Arabian Horse Association Inc. accepts no responsibility for any accident, injury or damage to any spectators, competitors, goods, property, pedestrians or vehicles. You are fully responsible for your horse and its actions.
7. No colts may be handled, ridden or driven by any person under the age of 18 years.
8. The show committee shall have the power without assigning any reason to issue a warning and/or excuse a competitor from the ring due to excessive use of whips, spurs, bits or due to any horse not being under proper control.
9. Any competitor whose conduct is considered to be ill mannered, aggressive or unsportsmanlike will be issued a warning and may be asked to leave the ring.
10. Condition of entry is that a "Registered Participant Application" form is completed and a \$10.00 levy (or participation fee) is paid prior to purchasing tickets if you are NOT a current financial member of the NSW Arabian Horse Association Inc, the Arabian Horse Society of Australia or a recognised affiliate of the Arabian Horse Society of Australia. An "AHSA Condition of Entry Declaration Form" must be completed by current financial members of the NSW Arabian Horse Association Inc, the Arabian Horse Society of Australia or a recognised affiliate of the Arabian Horse Society of Australia prior to purchasing tickets however no insurance levy is payable. Wristbands must be worn by all persons to enter any ring.
11. This show will be conducted under the rules and regulations of the current Arabian Horse Society of Australia Limited Rule Book, a copy of which is available at the show office.
12. All foals must be weaned. No mares will be allowed into the ring.
13. **All foals, except those competing in Arabian or Arabian Derivative classes, must be registered or eligible for registration with the respective breed societies, however pending registration is NOT acceptable for Arabian or Arabian Derivative foals. Therefore these horses MUST have a registration or foal recording number allocated. Foals competing in coloured classes must be registered or approved for registration on colour eligibility by the relevant colour Society**
14. Exhibits in classes for geldings must have been gelded. Exhibits registered as geldings are not eligible to compete in colt classes.
15. CLIPPING, TRIMMING & PRESENTATION: Foals and all youngstock must be exhibited as per their Breed Society regulations and Standard of Excellence. e.g. Welsh and Riding Pony Foals which exhibit an obvious body clip will not be judged. All RPSB entries must be plaited. Miniature Ponies must NOT be clipped.
16. The judge's decision is final - no person shall directly approach a judge with regard to a decision. Once a class has been judged, it cannot be re-judged.

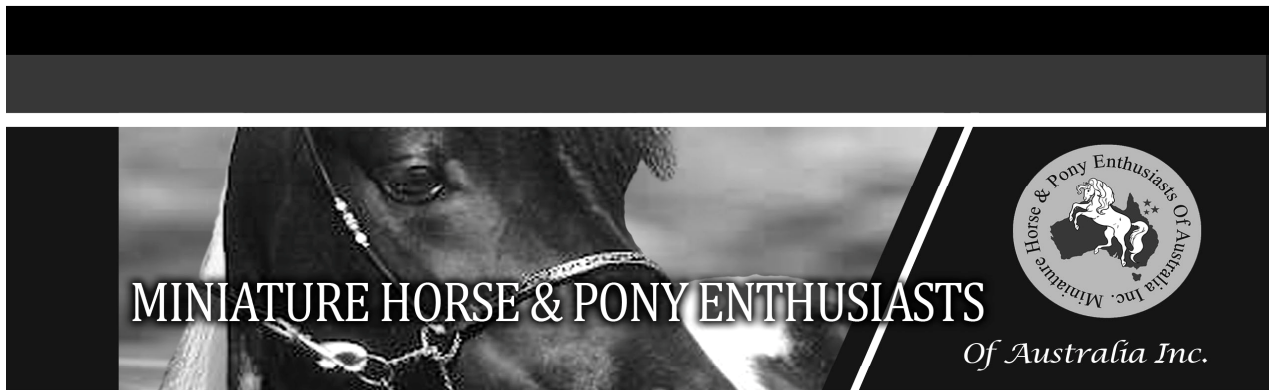

### Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sport activities and in particular this event, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this event.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the proprietors of the event organiser (hereafter referred to as the "Releasee") or others and I **voluntarily PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the **CANCELLATION** of my participation in the event and my immediate removal from my horse **NO MATTER** where that may occur. I further agree to abide by the Rules and Conditions of this show and the official Rule Book of the Arabian Horse Society of Australia. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear an approved safety helmet at all times whilst riding and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue the proprietors of the Arabian Horse Society of Australia Ltd and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise.

I understand that due to diseases such as equine influenza, the Department of Primary Industries, or other state or commonwealth government bodies may restrict or prevent the movement of horses, vehicles and personnel for a time period, otherwise known as a "standstill". I acknowledge that a standstill is a risk of competing and agree to pay any costs or expenses incurred by any person or organisation for and on behalf of my horse(s) as a result of the standstill.

### Effect of this Document

I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.
